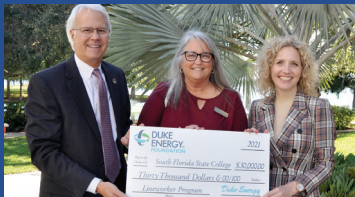

Governor DeSantis Presents \$415,000 in Funding for Truck Driving Program

SFSC'S TRUCK DRIVER TRAINING PROGRAM PROVIDES IN-DEPTH, HANDS-ON TRAINING TO FUTURE TRUCK DRIVERS.

Governor Ron DeSantis visited South Florida State College's Hardee Campus on Jan. 20 to present Dr. Thomas C. Leitzel, SFSC president, with a check for \$415,000. The money is earmarked for two state-of-the-art driving simulators for the College's Commercial Vehicle Driver Program.

Gov. DeSantis said he plans to make Florida the nation's No. 1 state for workforce education by 2030. This includes responding to the national shortage of truck drivers.

"The American Trucking Association

estimates that we're going to need, nationwide, 1.1 million new truck drivers over the next 10 years," Gov. DeSantis said. "Right now, there's a national shortage. Florida has been helping alleviate that. Companies are offering \$15,000 signing bonuses to encourage people to sign up and drive trucks. This is a moment when we can give people more opportunity and see them do well with little or no debt while also filling a need."

"We were thrilled to have Gov. DeSantis and Senior Chancellor Henry Mack from the Florida College System here," said Dr. Leitzel. "It is great that workforce matters in this state and we have a governor who rewards those efforts. The Florida College System can quickly respond to economic

Scholarships were presented by Tami Cullens, chair, SFSC District

The Florida Blue Nursing and Allied Health Scholarship was created to assist Florida college students who are pursuing careers that meet the state's growing need for skilled health care professionals. The SFSC Foundation provides a 50% match of the original award, as the funds must be matched dollar for dollar by private donors at the local level.

"Students participating in intensive healthcare programs are often unable to take on work outside of their studies," said Bateman. "Because of its commitment to education and statewide healthcare needs, Florida Blue has provided scholarships to aid these students in completing their programs and alleviating financial stress. These students will soon begin careers in fields that are critical in keeping our community safe and healthy."

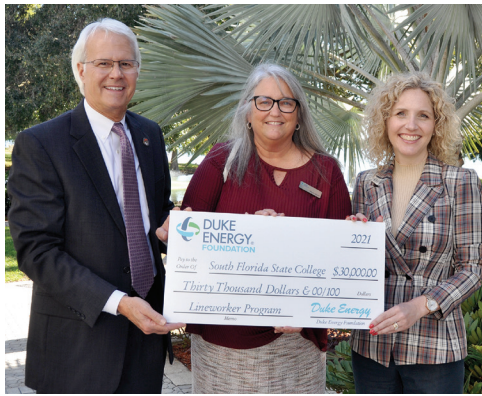

SFSC Receives \$30,000 Donation from Duke Energy Foundation

Last September, SFSC received another \$30,000 donation from Duke Energy Foundation to enhance the College's Electrical Lineworker Program through an initiative called "Increasing Training Opportunities for Electrical Lineworker Students by Expanding Training Capacity and Improving Safety."

"Supporting South Florida State College's electrical lineworkers is vital to developing a diverse workforce to help support the needs of the energy industry," said Nancy Dodd, Duke Energy Florida community relations manager. "Our continued collaboration with SFSC helps strengthen the vitality of the communities we serve, today and in the future."

The donation will be used to purchase climbing equipment and hardware, such as poles, transformers, and conductors, and to upgrade current vehicles, said Christopher Yeomans, electrical distribution professor. Some of the money will also purchase gym equipment to assist students in building the upper body strength required for this rigorous type of work.

Alum Balances Law Career With Military Service

FOR EDWARD LOHRER, SFSC WAS THE BRIDGE TO AN ARMY CAREER AND LAW SCHOOL.

As a young man growing up in Lake Placid, Edward Lohrer was curious to see what life held for him beyond the borders of Highlands County. He didn't have a plan at the time, but through self-determination he created the life he wanted. He is now a construction law attorney with the law firm Becker & Poliakoff in Fort Lauderdale.

As a 17-year-old high school junior, Lohrer made a commitment to join the U.S. Army because the \$30,000 bonus it was offering to new recruits would help him pay for college. Because he still needed to complete his senior year of high school, his Army recruiter steered him to SFSC's Adult High School program at the Lake Placid Center. By working at his own pace, he earned his diploma in four months and entered the Army a year earlier than he otherwise would have.

Lohrer was stationed at Fort Knox, Ky. His Military Occupational Specialty was 19K, a U.S. Army M1 Abrams armor crewman.

During combat, soldiers with this specialty operate M1 Abrams tanks. When his term of service ended in 1997, Lohrer left the Army to attend college with the hopes of eventually studying law at the University of Florida (UF).

In the process of applying to colleges, Lohrer visited SFSC's Admissions Office and learned that anyone who earned an associate in arts degree at a Florida community college would be accepted by a state university without taking the SAT or ACT exams. Lohrer received his associate in arts from SFSC in 1998 and his bachelor's degree

with a double major in criminology and political science from UF in 2000. While waiting to be accepted into law school, he enrolled in a master's degree program that focused on political campaigns.

In 2000 while attending the University of Florida Levin College of Law, Lohrer joined an Army Reserve unit in Gainesville to experience the order and camaraderie of Army life that he had come to miss. While in his third semester, Lohrer's Army Reserve Unit was deployed to Iraq in response to the terrorist attacks of Sept. 11, 2001. He had three days to put his affairs in order before reporting to duty. "I was the first person at the law school that this happened to," Lohrer explained.

After 14 months in Iraq, Lohrer returned to law school at the University of Florida. Because he had been in Iraq, He was hired as a summer associate with a two-attorney firm in Gainesville that introduced him to construction law. When he went back to law school for his final year, the firm asked him to stay on part time. He continued to work for them through the following summer.

After passing the Florida Bar Exam, Lohrer began applying to larger law

firms. "Construction law is a niche area, so I emphasized my experience on my resume. That's when I sent my resume to a firm in Fort Myers that concentrated on construction law. I was there for three years. Although I learned a lot while I was there and I was very close with a lot of the people there, it was a smaller firm handling smaller cases. I wanted to move onward and upward."

At the time, Becker & Poliakoff had an opening in their Fort Lauderdale office's construction law department. "They were looking for a younger attorney with some experience, and I fit that bill," Lohrer said. "Fort Myers has a small legal community. Becker had a Fort Myers office, so I'd gotten to know a couple of their lawyers. I got the interview with Becker and I've been with the firm since 2008." Lohrer remains active in the Army Reserve. He is the first sergeant of a drill sergeant unit in West Palm Beach and was recently selected to the E9 sergeant major list. To date, he has accumulated 23 years of military service.

Lohrer has advice for young people who are looking to the future. "At various points in my life, I didn't always have a plan," he said. "But I knew that I needed to do something, not just sit around. Time passes quickly and if you're unsure about what to do with your future, a lot of options exist. For me, I got experience in the military and got help with college. I was unsure what the college process was like or what I wanted to do, but I went to SFSC's Admissions Office and talked to people there. They gave me valuable information.

"Just go talk to people, get different perspectives, and learn about different options. When I see people who are adrift, there's always some reason not to move forward — like COVID-19. If you put in the effort, plenty of opportunities are available out there to explore. Life is a lot better if you're trying to improve yourself and you're staying busy and active."

Braden Beaney Becomes Take Stock's Leaders for Life Finalist

THE HIGH SCHOOL SENIOR IS NOW IN THE COMPETITION FOR A \$40,000 SCHOLARSHIP FROM THE ASOFSKY FAMILY FOUNDATION.

DeSoto County High School senior Braden Beaney is one of 12 finalists who are competing for six Take Stock in Children Leaders for Life Fellowships. Winners of a Fellowship receive a \$40,000 scholarship that covers non-tuition college expenses.

The Leaders for Life Fellowship is an initiative of the Asofsky Family Foundation, which awards the scholarship in partnership with Take Stock in Children. The SFSC Foundation is the lead agency for Take Stock within the College's service district of DeSoto, Hardee, and Highlands counties.

Beaney is eligible for the Fellowship due to his participation in Take Stock in Children. Because he is a dual enrollment student, he expects to graduate from DeSoto County High School and also receive his associate in arts degree from SFSC in spring

2022. He plans to study biology at the University of Florida with the goal of becoming a medical doctor in psychiatry.

In his young life, Beaney has learned to take charge in a crisis. He has assisted in caring for his stepfather, who has multiple sclerosis, and was his mother's caretaker as she recovered from a broken foot. In the workplace, he was a cashier at Winn-Dixie who trained new employees. He has participated in the National Honor Society, Students Working Against Tobacco (SWAT), Students Against Destructive Decisions (SADD), and the Green/Environmental club.

Dale Wolgast, a retired school principal from the DeSoto County School District, has been Beaney's Take Stock mentor for three years.

"One of the things foundations,

and those accepting students into universities, look for are completers," Wolgast said. "Braden checks all those boxes when it comes to finishing and completing what he starts. This scholarship would help him afford to go to a major university and go into the field of medicine he desires. He's one of the greatest kids I've ever met."

matters, and Gov. DeSantis recognized this. He boldly went after funds in the midst of the pandemic and said, 'We need to put people to work in the state of Florida.' Therefore, the Rapid Credentialing program was established. At SFSC, we say jobs is our favorite four-letter word. We enable our learners to get a job, keep a job, or be promoted in a current job. On behalf of all current students and all future students at SFSC, we are so grateful for the governor's support."

In 2020, SFSC was among the state institutions to be awarded funding through Gov. DeSantis' Emergency Education Relief (GEER) under the Coronavirus Aid, Relief, and Economic Security (CARES) Act. SFSC received \$292,096 plus an additional 25% through matching funds for a total of \$365,120. The money bolstered Rapid Credentialing, which assists in

educating and training residents who are unemployed, underemployed, or furloughed. Funds were used to enroll and complete students in short-term, in-demand workforce/career and technical education (CTE) credentialing and certificate programs.

Because SFSC's Commercial Vehicle Driver Program led the way with strong performance on its grant evaluation, Henry Mack, senior chancellor of the Florida Department of Education overseeing the Division of Career, Technical, and Adult Education, suggested the College move forward with purchasing truck driver simulators as teaching tools.

"We're seeing evidence that CTE graduates are earning the same median lifetime earning as baccalaureate degree earners," Mack said. "A case in point are the truck driver graduates of SFSC."

"We're excited about these

simulators because they will give our students an enhanced training experience," said Tina Gottus, SFSC's director of corporate and community education. "Students will learn how to drive in conditions such as darkness and high winds, as well as those we don't experience in Florida – the mountains and snow. They learn how to recover from incidents such as a tire blow out. Ultimately, they will become better drivers. When they make our roads safer, we all benefit."

SFSC's Commercial Vehicle Driver Program is a four-week course that offers in-depth training and provides connections with future employers. Joe Burke, a truck driver for 36 years, is the program's coordinator and instructor. The College accepts approximately 260 students into the program each year.
