## Dual Enrollment

Several types of acceleration mechanisms are available to qualified high school students, including Advanced Placement (AP), Dual Enrollment and International Baccalaureate (IB). A comparison of the different types of acceleration mechanisms may be found in the appendices.

South Florida Community College (SFCC) offers a strong Dual Enrollment program that allows qualified high school students to begin work early on their college degree while still in high school. Dual Enrollment is an educational program established by law in Florida (Florida Statute 1007.271) for district, private, and home-schooled high school students. Dual Enrollment enables high school students to take a college-level course that applies to high school graduation requirements and be awarded both college credit and high school credit for the college course. For example, upon successful completion of the college course ENC 1101 Freshman English, a high school student earns 3 college credit hours in English on his or her SFCC transcript, and the high school awards a corresponding English credit on the high school transcript.

Dual Enrollment:

- Helps a student accelerate his or her education goals
- Eliminates duplication between high school and college course content
- Increases the rigor and challenge of course offerings while in high school

Dual-enrolled students take college courses and earn college credits immediately. No comprehensive post-examination is required. Dual Enrollment also offers many more courses, including career and technical courses. Florida statute allows eligible students to take any college course as Dual Enrollment except remedial pre-collegiate courses, sports, recreation, or leisure courses. A formal agreement between the school district and the college identifies the requirements for early college Dual Enrollment programs. Students may attend Dual Enrollment classes available on the high school campus or on the college campus during the day or evening and during summer terms.

If you are a high school student in a DeSoto, Hardee, or Highlands county public school, a private school, or an approved home education program, you may enroll in SFCC's Early College/Dual Enrollment program provided you have met program requirements and have written permissions (guidance, principal or superintendent, and parent). You should consult a high school guidance counselor or SFCC advisor for more information.

## **Tuition is Free!**

### **Registration Fees**

You will **not** be charged fees for registration or books if you are enrolled in the Early College/Dual Enrollment program at DeSoto, Hardee, or Highlands county public schools if courses meet the core requirements for high school graduation credit. Tuition, books, laboratory fees, and transportation are free of charge to Dual Enrollment students who are taking college classes that apply toward high school graduation. For home-schooled and private school students, only tuition and lab fees are free to qualified students who are taking college classes that apply toward high school graduation. All dual-enrolled students are responsible for payment of other special course program fees, such as art supplies, automotive tools, health care uniforms. **Note:** College courses that exceed the requirements for high school graduation are considered “enrichment” courses and will require that the student pay for tuition, books, and fees.

### **Instructional Materials**

Course textbooks are purchased by the school district high schools and provided to students enrolled in Dual Enrollment classes on their high school sites. Individual students attending classes on SFCC sites must submit an approved voucher to purchase textbooks. After successfully completing the college course with a grade of C or higher, the student must return the textbook to her or his high school. All students must purchase their own books for courses not required for high school graduation.

### **Transportation**

Students are responsible for their transportation to and from classes held at college locations, unless otherwise arranged by their school district.

## **Important Notice to Parents and Students**

- Students taking Dual Enrollment courses are subject to the rules and regulations of SFCC as established in the SFCC Catalog and the SFCC Student Handbook.
- While in college courses, students are subjected to a learning environment that promotes an open exchange of ideas. Course content is presented on an adult level, and class discussions require a mature understanding of divergent viewpoints and the ability to think critically on controversial issues.

- High school students will be placed in classes with other college students that will likely include adults of all ages and backgrounds. Dual-enrolled students are expected to act as adults.
- Registration for available seats in all SFCC classes is on a first-come, first-served basis.
- Dual Enrollment students who receive a failing grade may have difficulty in meeting future admission requirements at colleges and universities, including financial aid and scholarship opportunities.

### **Student Eligibility**

Qualifications have been established to demonstrate that high school students are academically ready to successfully take on the challenge of college coursework. These requirements are as follows for all Dual Enrollment college credit and technical courses:

1. Students must be high school juniors and seniors for college credit, or sophomores, juniors, and seniors for technical Dual Enrollment.
2. Each term enrolled students must have a minimum 3.0 cumulative unweighted grade point average to take college credit Dual Enrollment and a 2.0 unweighted grade point average is required for technical Dual Enrollment courses.
3. Students must meet established cut scores on the SAT or ACT tests, or College Placement Test (CPT) to take college credit courses. Completion of the Test of Adult Basic Education (TABE) prior to enrollment is required for technical courses.
4. Parental and high school principal (and/or superintendent) permission is required.

### **Assessment**

All college students must take an approved assessment test and achieve acceptable scores to be placed in college-level work. For college credit courses, approved tests are the SAT, ACT, or CPT. For technical-credit courses, the TABE is the approved placement test.

Students may take the CPT twice per academic year (August to July) without charge. Students are required to wait 30 days before retesting on the CPT unless there are extenuating circumstances. The SFCC testing coordinator will determine if extenuating circumstances exist. SAT and ACT tests have no limit on retakes; however, a fee to take these assessments.

### **Code of Conduct**

Attendance at the college is a privilege, and to maintain the college ideals of scholarship and character development, the right is reserved to withdraw any student at any time for any reason deemed sufficient, and the student concedes this right to the college.

Each student, by registering, assumes the responsibility to become familiar with and to abide by the general regulations and rules of conduct of the college, including, but not limited to, those that are listed below.

Any of the following violations may constitute a form of disruptive behavior. Such disruptive behaviors, if they take place on campus or at a college function, may lead to suspension or dismissal from the college:

- Sale or consumption of alcoholic beverages on campus
- Illegal use or possession of drugs or narcotics
- Cheating in any form
- Stealing
- The use of indecent or abusive language
- Gambling
- Hazing
- Vandalism or destruction of property
- Falsification of records
- Unauthorized use of the college name
- Lewd or indecent conduct
- Behavior that intentionally acts to impair, interfere with, or obstruct the orderly conduct, processes, and functions of the college. This applies to acts conducted at any college campus or facility or off campus when relevant to such orderly conduct, processes, and functions.

Disruptive conduct shall include, but not be limited to, the following:

- Violence against any member or guest of the college community
- Theft or willful destruction of college property or of the property of others present at the college
- Interference with the freedom of movement of any member or guest of the college
- Obstruction of the normal processes and activities essential to the functions of the college community
- Deliberate interference with the rights of others
- Violations of a federal or state law, a county or city ordinance
- Repeated offenses of a less serious nature

### **Enrollment Process**

#### **Classes Conducted on an SFCC Campus**

Individual students who wish to enroll in a class on a college campus must see their high school guidance counselor to select courses and complete the SFCC application for Dual Enrollment. The application must include specific course titles, course numbers, and counselor signature. Students are required to complete the SFCC admissions application and show proof of successful completion of the ACT, SAT, or CPT for college credit courses, or the TABE for technical Dual Enrollment.

Students are to contact their designated campus high school guidance counselor to complete all approvals and then may proceed to the college campus to complete the registration processes.

College classes conducted on the SFCC campus will use the college schedule to start and complete classes. High school class schedules tend to run on an 18-week schedule, while college campus classes are on a 16-week schedule.

Students should be aware of the potential for differences in schedules and make arrangements accordingly.

#### **Classes Conducted on the High School Site**

Students taking courses offered on their high school campus will work with the high school's Guidance Office. The Guidance Office will disseminate the SFCC application and verify student eligibility (including proof of grade, GPA and test scores). The SFCC admissions office will review and process the applications prior to permitting students to register for classes at SFCC.

College classes conducted on the high school site may use the high school schedule to start and complete classes. High school class schedules run on an 18-week schedule, while college campus

classes are on a 16-week schedule. Students should be aware of the potential for differences in schedules and make arrangements accordingly.

### **Course Selection**

Participating public school students who attend Dual Enrollment classes may take any college academic or career course, with the exception of pre-collegiate remedial courses, sports, recreation, or leisure courses. However, each school district establishes which courses may be accepted for Dual Enrollment credit. Students are required to present an approved School District Approval Form to register away from their home campus. State law requires that Dual Enrollment students only enroll in 12 credit hours before earning assessment scores which place them into college-level courses in all three areas of reading, writing, and mathematics.

### **Choosing Courses**

It is vital that students have their course selections approved by their high school guidance counselor and/or an SFCC advisor. Dual Enrollment involves both college and high school credit, and course selection directly impacts student fulfillment of course requirements for both high school graduation and college degree completion. Students must be careful not to take college courses that do not apply toward their intended degree for these reasons:

- They may count as enrichment courses rather than required for graduation courses, thereby resulting in required tuition and fees.
- Taking excess hours that are not a part of the degree program requirements may influence future scholarship, grant or financial aid funding.

Your SFCC advisor can assist you in selecting the appropriate courses if you plan to transfer to another college or university program. Please consult with them on your course selection to ensure you are on the path to getting a college certificate or degree.

Students must also meet the established college course prerequisite and co-requisite requirements as identified in the course descriptions in the College Catalog. The College Catalog is available online at [www.southflorida.edu](http://www.southflorida.edu).

## **Course Equivalencies**

The Florida Department of Education maintains a list of Dual Enrollment courses identified to meet high school graduation requirements. The list, found on the Florida Academic Counseling and Tracking for Students Web site, [www.FACTS.org](http://www.FACTS.org), is not a full list of all allowed college courses, but it does list those which are most frequently taken by Dual Enrollment students in Florida. The list is useful to counselors, parents, and students in determining the high school graduation subject requirement satisfied by the college course (see SFCC Course Equivalency List).

In general, 3 college credit hours are the equivalent of .5 high school credits, with 6 college credit hours equating to 1 full high school credit. However, exceptions exist: The state list of Dual Enrollment courses identified to meet the high school graduation requirements mentioned above also indicates certain semester-length college courses deemed of sufficient rigor to earn a full high school credit. For example, ENC 1101 English Composition I, a 3-credit one-term college course, will also earn the student a full high school credit. High school credits are awarded per the status of the list at the time of student enrollment.

### **Early Admission**

Early Admission is a form of Dual Enrollment through which eligible high school students may enroll in college on a full-time basis in courses that are creditable toward the high school diploma and the associate or baccalaureate degree. Students enrolled in Early Admission attend all classes on a college campus and are exempt from the payment of registration, tuition and laboratory fees. Technical early admission is limited to students who have completed a minimum of 6 semesters of full-time secondary enrollment, including studies undertaken in the 9th grade (FS 1007.271.8). Early Admission students must meet all eligibility criteria for dual-enrolled students.

## **Grades**

Student performance and grading shall be evaluated in accordance with SFCC college credit and technical grading criteria and academic standards. Each faculty member will establish course grading criteria, post the information in the course syllabus and share with the student on the first day of classes. Dual Enrollment students must complete the college course with an A, B, or C grade to be considered successful. Dual Enrollment students who earn a grade of D, F or W will be permitted to retake the course only once as Dual Enrollment after they have sat out for one full academic term.

Students who wish to retake a course will do so at their expense, including tuition, textbooks, and transportation.

**All grades earned in Dual Enrollment classes will be posted on both the permanent college transcript as well as the high school transcript. These are permanent grades and will directly affect the student's ongoing college grade point average.**

A student is only allowed three total attempts in any college course. This includes withdrawals. Students with an excessive number of W grades, and students who repeat courses to improve their GPA, may jeopardize their admission to programs in the Florida State University System or other higher education institutions.

### **Course Drop or Withdrawal**

Students attending class on SFCC campuses must follow the deadlines posted in the College Catalog if they wish to drop or withdraw from a class. Like registration, all drops or withdrawals must be handled through both the high school guidance counselor and the SFCC Registrar's Office. Students enrolled in Dual Enrollment classes on their high school campus must contact their guidance counselor as a drop or withdrawal may negatively impact the student's grade and subsequent eligibility to take Dual Enrollment courses. To officially drop and/or add a Dual Enrollment course, the student must contact the high school guidance office or an SFCC advisor as appropriate.

Drop/add and withdrawal deadlines for students attending on high school sites are established annually and published in Academic Calendar located in the SFCC Catalog and Schedule of Classes. This information is readily available on the Web site at [www.southflorida.edu](http://www.southflorida.edu). Teachers and guidance counselors can also contact the SFCC Dual Enrollment coordinator for information regarding these deadline dates.

Florida state law has established that students enrolled in the same undergraduate college credit course more than twice, including withdrawals earning a W grade, must pay course fees at the non-Florida resident's tuition rates. This rate is approximately three (3) times higher than the Florida resident rate. Because of the seriousness of these possible outcomes, it may be to the student's advantage to delay retaking a course until graduating from high school with greater maturity and academic skills.

### **Transfer of Credit**

Dual Enrollment college credits are transferable to any public college or university within Florida and to many other public and private schools. Florida public universities and colleges have a common course numbering system, which greatly expedites transfer. Dual Enrollment students who wish to transfer to other institutions are responsible for checking with that institution to determine whether their SFCC credits will apply towards the general education requirement or as electives at that institution.

Dual Enrollment students who wish to remain at SFCC after high school graduation must submit a new admissions application to become a regular degree-seeking student.

### **General College Information**

#### **Faculty**

As Dual Enrollment is the delivery of a college course, all Dual Enrollment instructors are credentialed under Southern Association of Colleges and Schools (SACS) accreditation rules, whether they are full-time college professors, adjunct faculty members, or high school teachers. A high school teacher who wishes to teach a Dual Enrollment course must, therefore, present the same level of educational credentials and performance that are required of any faculty member hired by the college.

#### **Campus Resources**

Dual Enrollment students are entitled and encouraged to use SFCC resources including libraries, computer labs, electronic course management systems and tutorial labs.

#### **Parking**

SFCC provides ample parking to serve students and employees. A limited number of spaces are reserved for special permit parking. Students are required to obtain parking decals for their vehicles, if they wish to park on campus. This decal must be displayed on the left side of the rear bumper or rear window of automobiles and in a visible spot on motorcycles. Parking decals may be obtained from the SFCC cashier's office.

### **Cellular Phones/Other Electronic Devices**

Students must turn off or silence portable communication devices before entering classrooms, labs, or other areas of the college. Disruptions attributed to such devices will be considered conduct violations.

### **Academic Ethics**

The faculty of SFCC is committed to a policy of honesty in academic affairs. Conduct which you may be subject to administrative and/or disciplinary penalties, up to and including suspension or expulsion, includes:

1. **Dishonesty** consisting of cheating of any kind with respect to examinations, course assignments, or illegal possession of examination papers. If you help another cheat, you will be subject to the same penalties as the student who is assisted.
2. **Plagiarism** consisting of the deliberate use and appropriation of another's work without identifying the source and then passing off such work as your own. If you fail to give full credit for ideas or materials taken from another, you have plagiarized.

**In case of cheating or plagiarism:** The instructor may take academic action consistent with college policy that may range from loss of credit for a specific assignment, examination, or project to removal from the course with a grade of F. Your instructor and you should seek to resolve the problem to your mutual satisfaction. If you are unable to resolve the problem you may request action from the appropriate chair, program manager, program director or dean. See the Grade Appeals process listed in the College Catalog available on the Web site.

### **Equal Access/Equal Opportunity**

South Florida Community College pledges to provide equal access to education and employment opportunity to all regardless of race, color, gender, religion, age, national origin, marital status, political affiliation, sexual orientation, sexual preference, or disability. The administration of the college adheres to federal and state laws controlling equal access/equal opportunity. SFCC is a drug-free college and workplace. Illegal use of drugs or alcohol will not be tolerated on any SFCC campus, center, or at any SFCC sponsored event off campus. Alcohol and drug-free campus handouts are distributed to new students at orientation and to continuing students at their first registration in each academic year. These handouts describe standards of conduct that prohibit unlawful possession, use, or distribution of illicit drugs and alcohol on campus; health risks, applicable legal sanctions under the law; programs that address counseling treatment or rehabilitation/re-entry programs; and disciplinary sanctions that SFCC will impose on students and employees. You will find information regarding the Drug Free Campus and Drug-Free Workplace Program in the Student Handbook available on the SFCC Web site.

## STUDENT CHECKLIST FOR DUAL ENROLLMENT

- Make an appointment to discuss the Dual Enrollment options with your guidance counselor.
- Complete a Dual Enrollment admissions application.
- Complete the Dual Enrollment Approval Form (student and parent signatures are required). Your guidance counselor will verify, document and initial beside your unweighted GPA, grade and test scores.
- If you have acceptable test scores on record (SAT, ACT, CPT, TABE), your high school counselor will assist you with course selection. The counselor will also check for seat availability and will obtain the signature of the principal/designee.
- If you do not have acceptable scores on record, you will need to take the CPT or TABE. Your counselor will assist you with signing up for this test.
- The high school counselor sends the approval form to the principal for signature. The form is then sent to the superintendent (if required).
- The completed form is returned to the principal. A copy is placed in the student file and the original is given to the student to take to SFCC.
- The SFCC advisor verifies signatures, unweighted GPA, passing test scores, and grade requirements, and signs the form.
- The SFCC advisor will assist you in course selection if needed and refer you to the appropriate location for registration.
- Attend classes and complete course with a grade of C or higher in order to dual enroll in future Dual Enrollment courses.
- After course completion (within one week of the end of classes), return your textbook(s) to the high school bookkeeper.

## FREQUENTLY ASKED QUESTIONS

### Am I eligible to dual enroll?

To be eligible you must:

- Be in grade 10 or higher for technical Dual Enrollment and grade 11 or 12 for academic Dual Enrollment.
- Have a 3.0 unweighted grade point average for academic Dual Enrollment, 2.0 unweighted grade point average for technical Dual Enrollment.
- Have approval from the principal (and superintendent if required by the school district).
- Have no severe behavior problems.
- Meet the minimum testing requirements (CPT, SAT, ACT for academic courses and TABE for technical Dual Enrollment).

### How do I get started with Dual Enrollment?

Make an appointment with your guidance counselor, complete the SFCC Dual Enrollment admissions application, and the Dual Enrollment Approval Form.

### How do I know which courses to take?

You should discuss your courses with your guidance counselor. Look for courses that help you:

- Meet your subject area requirements for high school graduation.
- Complete a career and technical program of study.
- Count towards your A.A., A.S. or A.A.S. degree (an SFCC advisor will assist you to identify the appropriate courses).

### I've never dual enrolled before. Which courses should I take first?

If you have a 3.0 unweighted grade point average and meet the minimum test score and grade requirements for academic Dual Enrollment, it is recommended that you take ENC 1101 (College Composition) and SLS 1501 (Master Student/College Success). The College Composition class is a pre-requisite for most of the A.A. degree courses. The Master Student/College Success class is a good orientation class for college.

### **How do I know which courses meet high school subject area requirements?**

A listing of the college courses that meet particular high school subject area requirements is found in the appendix of the SFCC Dual Enrollment Parent and Student Guide. The statewide listing of approved Dual Enrollment equivalency is available on the FACTS.ORG Web site.

### **Which courses do I need for SFCC degrees or programs?**

The requirements for all SFCC degree and certificate programs can be found in the SFCC Catalog located on the SFCC Web site at [www.southflorida.edu](http://www.southflorida.edu).

### **Can Advanced Placement (AP) English substitute for ENC 1101 (College Composition) when required as a prerequisite of a course?**

If you have taken AP English and scored a 3 or higher on the AP exam, you may substitute AP English as a prerequisite.

### **Which courses taught at my high school are eligible for technical Dual Enrollment?**

Any course listed on the Statewide Technical Dual Enrollment Equivalencies found at [www.careerconnection.org](http://www.careerconnection.org) and offered by your SFCC campus is eligible for qualified students to enroll in. Each instructor must be approved by SFCC and meet SFCC credentialing criteria.

### **Are there any academic criteria I must meet as a Dual Enrollment student?**

You must have an unweighted high school GPA of 3.0, be in the 11<sup>th</sup> or 12<sup>th</sup> grade, and have acceptable CPT, ACT or SAT scores to enter the college credit Dual Enrollment program and a 2.0 unweighted high school GPA, be in the 10<sup>th</sup>, 11<sup>th</sup> or 12<sup>th</sup> grade, and have completed the CPT or TABE for technical Dual Enrollment.

### **Does the Dual Enrollment grade count on my high school transcript?**

Yes, the grade is listed on your high school transcript and counts toward high school graduation requirements. The grade is also listed on your SFCC transcript; hence, Dual Enrollment has two grades (a high school grade and a college grade) for each course.

### **Must I pay any tuition or book fees for Dual Enrollment courses?**

No, the school district and SFCC cover all expenses for tuition, lab fees and books for Dual Enrollment courses unless you are home schooled or attend a private high school.

### **When do I register for courses?**

Registration deadlines are determined by the high school and SFCC academic calendar. Students are encouraged to enroll in classes as soon as possible as classes will fill and seats will no longer be available.

**How do I register?**

Your high school guidance counselor will help you with the process.

**Why should I consider Dual Enrollment?**

The college credits you earn may count toward a SFCC occupational certificate program of study, an Associate in Science degree, an Associate in Arts degree, or apply toward a baccalaureate degree. Discuss what options may be available with your guidance counselor and with a SFCC advisor. The biggest advantage for you is a free college education and a head start on gaining the skills needed for a career!

## SFCC DUAL ENROLLMENT STUDENT CONTRACT

Success in Dual Enrollment college classes is dependent upon academic readiness, social maturity, and motivation. Students who choose to enter Dual Enrollment classes are subject to the same rules and regulations as regular adult college students. Class makeup and content may contain mature, adult students from diverse backgrounds and life experiences. Additionally, course content is college level and may contain material, situations, and examples that may possibly offend immature students. Students choosing to take college classes do so with the understanding that course rigor and content is intended for a mature, college-level student.

The high school student on the college campus experiences the same freedom and lack of direct supervision that would be provided for any adult. There is no process to monitor student social situations or behavior. Students are on their own merit and behavior when taking classes on the SFCC campus and are expected to conduct themselves as adults.

College course-level expectations include, but are not limited to the following:

- Students are expected to be in class from the first day and should attend class regularly. Students may be withdrawn by the instructor for excessive absences that equates to two week's worth of college work.
- Two to three hours of homework should be completed for each hour spent in class.
- Assignment deadlines are firm.
- Any letter grade below a C will not count as credit toward satisfaction of the General Education requirement or the Gordon Rule requirements for college credit courses.
- Any letter grade below a C in any Dual Enrollment course will remove the student for eligibility for the following full term (fall/spring).
- All grades are calculated in a student's GPA and will appear on the permanent college transcript.
- All grades, including a W for withdrawal, become a part of the student's permanent college transcript and may affect subsequent postsecondary admission.
- While appropriate for college-level study, course materials/class discussions may reflect topics not typically included in secondary courses which some parents may object to for "minors." Courses will not be modified to accommodate variations in student age and/or maturity.
- Student/parents should consult a college counselor and/or advisor regarding the selection of courses to meet college degree requirements or for transfer to a specific course of study at another institution.
- Poor selection of classes may result in excess college hours and/or impact availability of future financial aid and/or/scholarship funding.
- Transfer of Dual Enrollment credit to out-of-state institutions may or may not be recognized.
- All students attending Dual Enrollment courses on the high school campus will have final exams approved, collected and returned to the college for one calendar year.

College-level Dual Enrollment science courses taken without a lab component will be awarded 0.5 high school science credits.

Note: Section 1003.43(1), Florida Statutes, states that high school graduation requirements include successful completion of "three credits in science, two of which must have a laboratory component." Regardless of the number of science credits earned through Dual Enrollment, the requirement of two sciences with a lab component must be met to graduate.
