This is a residence life facility dedicated to providing a warm, welcome environment that is safe and secure. Housing is available for full-time students of South Florida Community College only. Separate accommodations are available for male and female students. It is located in Avon Park, approximately three miles north of the Highlands Campus; however, public transportation is NOT available.

All residents are expected to live according to community standards conducive to a wholesome collegiate experience. Specific regulations pertaining to student residents include the following:

1. Co-educational visitation is prohibited in the individual residence facility rooms (behind metal doors). Alternative space is provided for socializing.
2. Alcohol and controlled substances (drugs) are not allowed on the premises of the residence facility.
3. Firearms and other weapons, fireworks, and ammunition are not allowed on the premises of the residence facility.
4. Candles are not allowed in the residence facility.
5. Certain specific quiet hours must be observed daily to facilitate study.
6. Tobacco use of any kind is prohibited on the premises.

Additional regulations are outlined in the *Jacaranda Residence Facility Student Handbook*.
