- 6. Dr. Leitzel reported that Dr. Revell will submit this week to SACSCOC prospectus documents for two new programs Biofuels Technology and Biomass Cultivation.

SUBJECT: STUDENT LIFE, ACTIVIES, ATHLETICS, AND SERVICES

Dean Annie Alexander-Harvey will introduce the SGA leadership and other clubs and organizations. Members will share accomplishments and high points of the academic year. Our academic and athletic teams are included.

SGA Clubs and Organizations - This has been a student driven, fun filled year as the students have celebrated old traditions and started new ones as well. The events and activities of the year were set forth by the SGA E-Board (executive board) during the fall of 2013.

- We reactivated two clubs this year, the Rotaract Club & the Philosophy Club. We also merged two clubs, the Choir Club & the Drama Club, to form the Performing Arts Club.
- Art Club has had a great 2013-2014 year! We started the year with a field trip to the Ringling Museum of Art, and fund raisers such as bake sales, silent auction, and two soup bowl events that raised money for 14 art club students to visit art museums and sights in NYC in February, 2014. We assisted the MOFAC (Museum of Florida Art and Culture) with volunteer time and making refreshments for their receptions. This spring we took more students to the Ringling Museum of Art for their "Now" event of Postmodern art. We also visited the Dali Museum to see Dali and Andy Warhol work, as well as the St Pete Fine Arts Museum for the "New Media Show." We had active participation in SGA and all their events including the "College Week" of games enjoyed by all.
- The Health Occupations Students of America organization which formed their organization last year has performed well at their regional, state and national conferences. Just last year 2013 we had 11 Students place in the Top 5 at State, Regional, & National Competitions respectively in various events such as Nutrition, Home Health Aide, & Nursing Assistant. We have had a very successful two years since we started this organization. We have been recognized at the Regional, State, and National levels. We have awesome students we are dedicated to our organization.
- Rotaract is a branch of Rotary International for college students. While Rotary clubs serve as sponsors, Rotaract clubs decide how to organize and run their club and what projects and activities to carry out. Like Rotary clubs worldwide, Rotaract's mission is service above self and

- function as an international network of young leaders with a common purpose of serving their communities.
- Phi Theta Kappa began the year by hosting a "Commit to Completion" signing event in conjunction with "Club Rush" this fall and more than 150 SFSC students signed a banner committing to complete their certificate or degree program! They continued an initiative of Phi Theta Kappa to promote the use of CollegeFish.org; a comprehensive database designed to connect transfer students with scholarships and universities and is now open to all students not just PTK members. The annual "Angel Tree" project at Christmas was a huge success and members took the gifts collected to the Oaks at Avon nursing home and sang Christmas carols to the residents. Club members also served as ushers for the SFSC Children's matinee performances held on campus and will assist with the commencement ceremony. The club raised \$700.00 for Relay for Life by holding Bake Sales each month and will participate in tackling the cure at the Avon Park Relay for Life event on May 2nd. The Phi Theta Kappa National convention will be held this month in Orlando and the club is excited to take 7 members to attend the convention.
- Student Nurses Association (SNA) has had an active year. SNA members attended the Florida Nursing Students Association Conference in Daytona where students were able to attend classes and network with student nurses across Florida. In addition, two students represented our college at the National Student Nurses Conference. Students were active with fundraisers and were able to make donations to Relay for Life, Samaritan's Touch, and Florida Hospital Breast Cancer Program.
- The International Student Organization celebrated "Hispanic Heritage Month", 5 members attended the "Black, Brown and College Bound Summit." South Florida State College was 1 of 17 colleges and universities that sponsored the event. Several students visited the University of Central Florida for a 1 day informational session addressing issues such as the transfer process into the university, housing and additional financial assistance for students. This session was conducted be former SFSC SGA alumni's and club members.
- The Performing Arts Club merged the Drama Club and Choir Club this year. They sang for the
 Veteran's Day Program and the Foundation Holiday Luncheon. They volunteered for a
 production at Highlands Little Theatre and volunteered for the Spring Dixie Youth Baseball
 Opening Day. They have been working on the Improv skills and had hoped to see a show in
 Sarasota but the show was cancelled. They promoted SFSC talent by sponsoring a Talent Show
 for students and faculty.
- The College Republicans assisted the local Republican Party with their open house and volunteered to work the booth at the Highlands County Fair. The College Republicans also hosted Representative Cary Pigman to the campus to present to students as well as do a Q & A. Plans are underway to visit Tallahassee and meet with the Governor and the Cabinet.
- The SFSC Campus Christian Club is a non-denominational group that meets bi-monthly to fellowship, have Bible study, prayer and worship. Our members have studied a variety of topics this year. We are excited for the group to attend a showing of "God's Not Dead" to reinforce the beliefs of these students as well as further facilitate the year-long discussions of the group.
- The Honors Ambassadors is the student organization for Honors Students, promoting student opportunities for high academic achievement at SFSC at orientations, workshops, and career fairs. The Honors Program this year has ten graduates. Five graduated in fall 2013, and five will graduate in spring 2014.
- Phi Beta Lambda has had a very busy 2013-14. It kicked off in the fall, with a trip to the National Fall Leadership Conference. They then began a steady fundraising drive to raise money to go to their District and State Level Competitions which they placed very well in. They are now working to raise funds to take their group to Nashville in June to the National Competition that they qualified for based on their performance at the State & District Level.

Athletic Teams

Panther Student Athletes from Baseball, Softball and Volleyball teams will be presented by respective coaches and will introduce themselves. Coach Hitt, Athletic Director, will also share some season highlights.

Student Government

Besides the very active clubs, the Student Government of SFSC planned and carried out wonderful events this year which inspired learning and fun. These included: End of Semester Party in the Fall and Spring with the Fall consisting of a Hollywood (Dress as your favorite Celebrity) themed Casino Night, and the Spring will be a Pool Party with a Bar-B-Q; Panther Pride, a pep rally designed to boost athletic involvement throughout the year; student forum with Dr. Leitzel; a Student Leadership Summit designed to provide quality speakers and workshops to aid students and sharpen their leadership skills; Panther 5K with a Club contest to determine which Club had the most participation at the 5K; state leadership conference; intramural basketball, & soccer; College Week, a week-long series of events that was participated in by over 20 teams comprised of students & faculty/staff that leads to an overall champion; fall and spring club rush to encourage student participation in organizations; and general SGA meetings every Wednesday. Student Leaders were also very active in the Campus-Wide orientation, GPS. They assisted in many different areas within GPS, but mainly provided a student led session that covered everything from college expectations to how to get involved with the Student Government Association.

SUBJECT: POLICY IMPLEMENTATION: NEW POLICY 1:18: SUBSTANCE ABUSE TESTING

Approval is recommended to establish a new Policy 1.18 Substance Abuse Testing to provide awareness and approval for substance abuse testing of student athletes and students in academic programs which require drug/alcohol testing. Currently, several of our allied health programs practice in clinical settings which require evidence of drug screening. Staff have been sending students to a local laboratory testing facility prior to clinical experiences, and to date, no tests have indicated evidence of substance abuse. Our Athletic Department has requested the authority to perform in-house unannounced and reasonable suspicion testing followed by confirmation testing (if necessary) to ensure that our student athletes do not use illegal or banned substances or misuse medications or other substances. Our policies currently do not allow illegal use or misuse of alcohol and drugs, but we have no program currently in place to monitor student athletes for compliance. Approval of this policy will provide for the President to develop detailed procedures to ensure legal and appropriate monitoring and compliance with other policies and rules already in place.

This proposed new policy is offered for consideration.

AND STUDENT SERVICES

South Florida State College (SFSC) is committed to providing a campus environment free from the abuse of alcohol and/or the illegal use of alcohol or other drugs, as set forth in SFSC District Board of Trustees Policy 1.07. The use of illegal drugs and performance-enhancing substances, as well as the misuse of tobacco, alcohol, legal drugs, and over-the-counter medications and supplements, is inconsistent with the standards expected of SFSC students and is thus prohibited.

The college president is authorized to develop administrative procedures to provide for substance abuse testing of student athletes and students in specialized programs. These procedures will include provisions for notification, exceptions, testing, chain of custody provisions, disciplinary consequences, complaint procedures, and enforcement.

Cross Country is currently available at all high schools within the SFSC service district and has great involvement statewide from these high school runners. Currently, many four-year institutions provide the sport of Cross Country as does Chipola College and Pasco Hernando State College. SFSC would be the third state college, and the only south central college, to offer this intercollegiate sport.

SUBJECT: EQUITY PLAN UPDATE

In compliance with the Florida Educational Equity Act (§1000.05, Florida Statutes (F.S.)) and the Florida College System Employment Equity Accountability Program (§1012.86 F.S.), South Florida State College maintains a comprehensive equity plan which documents the college's continual efforts to address areas of underrepresentation of minorities in its academic programs, activities, and employment. The plan is updated annually and submitted to the Office of Equity and Civil Rights Compliance, Division of Florida Colleges, Florida Department of Education in the form of the Annual Equity Update Report.

The report articulates several measurable goals and objectives related to promoting diversity and ensuring equal access and opportunity for admission to and employment in educational programs and activities; corresponding strategies and timelines for accomplishing these goals and objectives are provided. The report also furnishes a thorough description of the process for reviewing policies and procedures related to equal opportunity, non-discrimination, and employment accountability as prescribed in the aforementioned statutes. Included in these descriptions is the procedure for granting continuing contract status to faculty-and-evaluating the college president and other senior level administrative staff.

The process used to prepare SFSC's Annual Equity Update Report entails extensive coordination, data and information collection, analysis and input from several key college faculty, staff, and administrators. The report is submitted in electronic and hard copy formats to the Director, Equity and Civil Rights Compliance, Division of Florida Colleges, Florida Department of Education. It subsequently undergoes a thorough review to ensure compliance; recommendations for improvement, if required, are provided to the college.

The report is forwarded to the President of the Senate and to the Speaker of the House of Representatives, each year, to provide a system-wide progress report on equity and access.

The presentation of the Annual Equity Update Report at the April 23, 2014 meeting of SFSC's District Board of Trustees includes the college's responses to recommendations from 2013 and seeks the board's acceptance of the 2014 report.

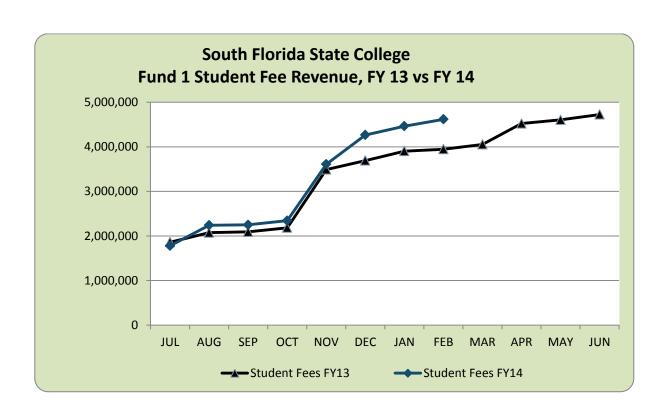

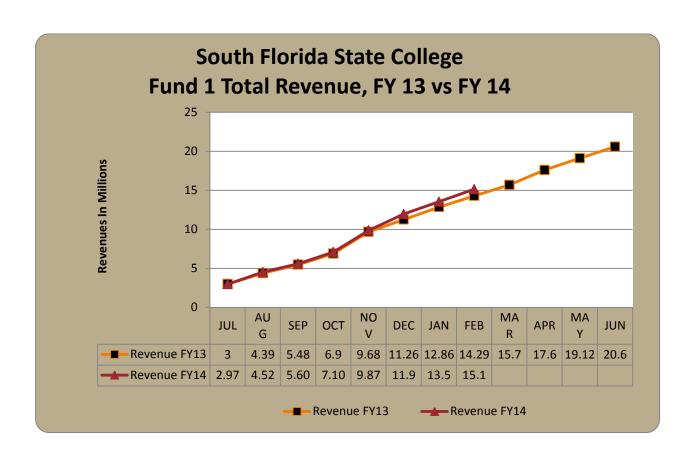

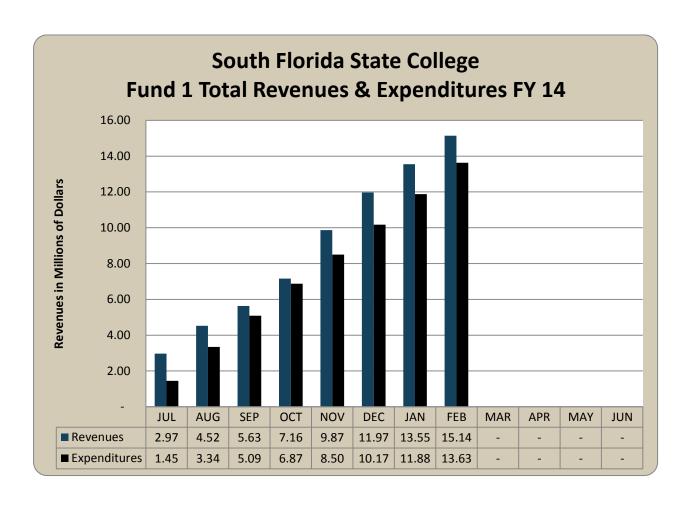
