# **EMT-Paramedic Program Admissions Requirements**

Print this application. All criteria will be fulfilled and documentation complete and returned to the Health Sciences Staff Assistant prior to Program start date.

#### MANDITORY ADMISSIONS PACKET ATTACHMENTS

- 1. Copy of State of Florida Driver's License (Attachment 1).
- 2. Copy of current CPR Card. MUST BE ONE OF THE FOLLOWING (Attachment 2).
  - a. American Heart Association "Professional Rescuer"
  - b. American Red Cross "CPR for the Professional Rescuer"
- 3. Proof of completing a State of Florida approved EMT-Basic training program.
- 4. Before the end of the Fall Sem<mark>es</mark>ter, you must pass and produce proof <mark>of</mark> a valid State of Florida EMT-Basic certification.

#### Priority for admission will be given as noted below:

Currently employed with Rural EMS or Fire Rescue department.	40 points
Resume and Essay.	10 points
College Degree (25 points) Core Classes for AS Degree in EMS.	25 points
Interview	10 points
EMS/Rescue Experience	15 points
Total	100 points

After evaluation of the applications by the EMS Programs Staff and Medical Director, the 18 applicants scoring the highest point value will be allowed entrance into the Paramedic Program.

After registration and payment of fees, the student must complete a background check according to the SFSC Health Sciences Background Check Policy. Students who are unable to attend this program as a result of the background check will forfeit his/her acceptance in the program. Any cost associated with the background check will NOT be refunded.

After registration and payment of fees, the student must submit to a 10 panel drug screening. Students who are unable to attend this program as a result of a positive drug screening will forfeit his/her acceptance in the program. Any cost associated with the drug screening will NOT be refunded.

Please provide copies as attachments and not originals. Completed packets will become property of the SFSC EMS Department. All information in this packet is to be used by staff only and is held in the strictest of confidence. Thank you for your honesty.

#### **SFSC Paramedic Program Frequently Asked Questions:**

- Q How long is the course?
- A 1200 contact hours (11 months)
- Q What is the class schedule?
- A The class is scheduled on a "shift-friendly" basis. Due to the fact the most EMT-Basic jobs are scheduled on a 24 hour on duty and 48 hours off-duty, class is scheduled accordingly. The decision as to what shift the class will be scheduled is based on the majority of the students enrolled. All class days are scheduled from 9am-5pm.
- Q Does the class times include lab, clinical, and field internship?
- A The class times include laboratory, but hospital clinical and field internship are scheduled outside of normal class hours.
- Q What is Hospital Clinical Experience?
- A It is a series of 10-12 hour shifts spent in the Emergency Department, Intensive Care Unit, Operating Room, and Obstetric Units of local hospitals. During these shifts you will perform assessments and skills learned in class and lab on patients in these areas. This portion of the training is under the direct supervision of a Program Preceptor (Total 120 hours).
- Q What is Field Internship?
- A It is a series of 8-12 hour shifts that you ride on an ambulance and function in the capacity of a Paramedic under the direct supervision of a Program Preceptor (468 hour minimum).
- Q Can I have a criminal record and still be a Paramedic in the State of Florida?
- A It is possible to have a criminal history and be certified as a Paramedic in the State of Florida. All Paramedic students who complete the Program have to apply with the State of Florida in order to take the Florida Certification Exam. The contact information for this agency is listed below:

- Q Can I have a bad driving record and work as a Paramedic?
- A Driving is a very important aspect of the Paramedic job and prospective employers will not look favorably on a poor driving record.
- Q What are the physical requirements of the Paramedic Program?
- A Students should have manual dexterity to be able to perform minute tasks with both hands and be able to lift and carry 100 pounds. You will be required to have a physical examination with a physician signature stating that you are physically capable of performing the tasks of a Paramedic. - Q What is the cost for the class?
- A Approximately \$1,500.00/Semester (including books and uniform). Total cost approximately \$5,500.00.

#### **Emergency Medical Technician-Paramedic**

**Purpose:** This course is the third step in the training of pre-hospital care professionals. This course is designed to train persons for the occupation of Emergency Medical Technician-Paramedic. This training is geared for the advanced life support level.

#### **Objectives:**

Upon completion of this program, the student will:

- 1. Recognize the nature and seriousness of a patient's illness/injury in order to accurately administer the proper emergency medical care on an EMT-Paramedic level of training.
- 2. Administer appropriate emergency care based on their training to stabilize the patient's condition.
- 3. Lift, move, position, and otherwise handle the movement of the patient in such a way as to minimize further injury or illness.
- 4. Fulfill all written and practical objectives as required by the USDOT National Standards Curriculum.
- 5. Be eligible to take the State of Florida EMT-Paramedic State Board Exam.
