2016
Annual Security & Fire Safety Report

The Clery Act requires South Florida State College (SFSC) to publish an annual report that contains statistics for the previous three years concerning reported crimes that occurred on campus, at off-campus buildings owned or controlled by SFSC, and on public property immediately adjacent to and accessible from the campus. The report also includes institutional policies concerning campus security, such as the policies concerning alcohol and drug use, crime prevention, the reporting of crimes, sexual assault, and other matters.

CRIME STATISTICS

Crime statistics for the past three years are contained in Appendix A.

TIMELY WARNINGS

In the event that a crime or situation occurs either on or off campus that poses a threat to the college community, a timely warning will be issued by the SFSC administration. Victim's names may be withheld from the warnings to ensure confidentiality. These warnings will be posted on the SFSC website homepage. SFSC uses Blackboard Connect to disseminate mass text announcements to students, faculty and staff. As a redundancy, information will also be sent out through the college e-mail system to all students, faculty and staff.

ANNUAL DISCLOSURE OF CRIME STATISTICS

The SFSC Security Department prepares this report to comply with the Jeanne Clery Disclosure of Campus Security Policy and Crime Statistics Act. A full text of this report can be found on the SFSC website, under Administration (link), on the tab called Security. This report is prepared in cooperation with the Highlands County Sheriff's Office, Desoto County Sheriff's Office, Hardee County's Sheriff's Office, Sebring Police Department, and the Lake Placid Police Department. Campus crime, arrest and referral statistics include those reported to SFSC's Security Department, to designated campus security authorities including academic deans, deans of student services, the athletic director and athletic coaches, and law enforcement agencies.

Each year notification is given to all enrolled students. The notification provides the website to access this report http://www.southflorida.edu/wp-content/uploads/sites/3/2015/03/Security_CSR.pdf . Faculty and staff receive similar notification through the college e-mail system and/or their payroll liaisons. A written copy of this report may also be obtained from the Vice President for Administrative Services' office, Building F, room number 128 on the Highlands Campus.

REPORTING OF EMERGENCIES AND CRIMINAL ACTIVITY

South Florida State College has developed a set of guidelines for reporting emergencies and criminal activities. It is important to note that each emergency situation or criminal activity has different circumstances requiring different actions. Each action should afford the safety and security of victims and other participants. Reporting guidelines are published in the *Student Handbook, Faculty Handbook, Adjunct Faculty Handbook, Employee Handbook and The Employee Safety Manual*.

Criminal actions and emergencies should be reported as they occur to the Security Department or campus/center director. This allows security staff to respond as soon as possible. In addition to completing an internal Incident Report, the security officer/director, and/or first responder will contact the appropriate law enforcement agency, when the victim of such crime elects or is unable to make such a report. Any violations, infractions or potentially hazardous situation should be reported immediately to Security. Evidence should be preserved for use in possible criminal prosecution. In the event of a crisis, immediate danger, injury or criminal activity, the victim/witness is advised to first call the local law enforcement, fire or emergency service. CONFIDENTIAL REPORTING

The SFSC Security Department encourages anyone who is the victim of or witness to any crime to promptly report the incident to the Security Department. Because college reports are public records the college cannot hold reports of crime in confidence.

ACCESS POLICY

During business hours, the college will be open to students, parents, employees, contractors, guests, and invitees. During non-business hours, access to all college facilities is by key, if issued, or by admittance via security staff.

In the case of an emergency closing, the college will only admit those with prior approval.

CAMPUS SECURITY

Campus Security personnel are not law enforcement officers and do not have the authority to arrest individuals. Security officers have the authority to ask persons for identification and to determine whether the individuals have lawful business at South Florida State College. Security officers have the authority to issue parking violations to students, faculty and staff. Criminal incidents are referred to local law enforcement agencies that have jurisdiction for the individual campus or center. The Highlands County Sheriff's Office has jurisdiction over the Highlands Campus, while the enforcement at other campuses and satellite centers is the responsibility of local law enforcement. Security personnel are responsible for the safety of personnel and the safety of buildings and their contents. The college works directly with local law enforcement agencies to report criminal activities and incidents. During the 2016-17 school year the college has contracted with the Highlands County Sheriff's Office to have a College Resource Deputy (CRD) stationed at the Highlands Campus. The CRD has full jurisdiction to enforce all laws and maintain peace.

CONFIDENTIAL REPORTS

All reports will be explored. SFSC does not have procedures for voluntary, confidential reporting of crime statistics. Violations of the law will be referred to law enforcement agencies. When a potentially dangerous threat to the college community arises, timely warnings will be issued by college webpage announcement, e-mail, text messages, in-class announcements or other appropriate means.

MONITORING OFF-CAMPUS CRIMINAL ACTIVITY

South Florida State College does not participate in recording student criminal activity in off-campus sorority or fraternity housing, since it is not applicable in our community environment.

SECURITY AWARENESS AND CRIME PREVENTION

Periodically throughout the academic year, a safety and security awareness presentation is given to Students, staff and faculty groups. In addition, South Florida State College has subscribed to *SafeColleges'* online safety training program. This program includes a variety of topics which include, alcohol awareness, Campus SaVE act, Bystander Intervention and Title IX compliance. Training is made available to all staff and students.

The college also offers orientation programs for new students that include safety information. Current and continuing students, along with staff, are provided with information regarding personal safety.

Safety Precautions:

All members of our campus community must remain vigilant and take the following simple precautions:

- * Park your vehicle in a well-lit area, making sure your vehicle lights are off, keys are in your hand, and all doors are locked.
- * Do not leave valuables in parked vehicles.
- * When approaching a parked vehicle, check the surrounding area for strangers.
- * Make arrangements with the Security Department or satellite campus directors for escorts, if needed.
- * Report any suspicious incidents or individuals to Security or satellite campus Directors.
- * Report all campus crimes you see.
- * Never leave personal property unattended on campus.

EMERGENCY RESPONSE AND EVACUATION PROCEDURES

South Florida State College will immediately notify the campus community of a significant emergency or dangerous situation involving an immediate threat to the health or safety of students or employees occurring on the campus. The institution will, without delay, and taking into account the safety of the community, determine the content of the notification and initiate the notification system, unless the notification will, in the professional judgment of the responsible authorities, compromise efforts to assist victims or to contain, respond to, or otherwise mitigate the emergency. In the event the emergency extends beyond the boundaries of the college campus, law enforcement having jurisdiction will be contacted. Pending the nature of

the emergency, the county emergency operations center (EOC) or health department may be used to disseminate information to the affected public areas.

When emergency information is received by college personnel, the information is immediately conveyed to the college's administration. The information is analyzed, confirmed for accuracy and validated as a significant emergency. The college president, or designee, will produce a warning message and initiate the notification system. South Florida State College performs an annual test of the emergency response system. During the 2015 year we conducted one announced exercise on December 18 at 2:15pm. In addition to our announced exercise, our fire pull stations are exercised annually during their maintenance servicing.

MISSING STUDENT NOTIFICATION

Each student living in an on-campus student housing facility has the option to register a confidential contact to be notified in the case that the student is determined to be missing and that only authorized campus officials and law enforcement officers in furtherance of a missing person investigation may have access to this information. To register a confidential contact, please see the SFSC's Residence Life Coordinator.

All official missing student reports will be immediately referred to the local law enforcement (within 24 hours of receipt of the initial notification), whether a confidential contact has been provided or not. In the event that a student is less than 18 years of age and is not emancipated, their parent or guardian will be notified.

An individual seeking to file a report that a student has been missing for 24 hours can contact any of the following: The Dean of Student Services, SFSC Residence Life Coordinator or the SFSC Security Department.

Once a report has been received, the SFSC residential staff will conduct a preliminary investigation in order to verify the situation and to determine the circumstances which exist relating to the reported missing student.

1. A staff member will attempt to contact the subject student via his or her telephone.
2. If the subject student cannot be reached by telephone, two staff members will visit the room of the residential student in question to verify his/her whereabouts and/or wellness and deliver a message to contact a parent or family member who is searching for them.
3. If the residential student is not at the room, but the room is occupied, the residence staff will attempt to gain information on the student's whereabouts and/or wellness through questioning the occupants.
4. If there is no response when the staff members knock on the door of the room or there are occupants who do not know of the subject student's whereabouts, the residence staff will enter into the room in question, by key if necessary, to perform a health and safety inspection. The staff members will take note of the condition of the room and look for visible personal property (wallet, keys, cell phone, clothing, etc.) which might provide clues as to whether the subject student has taken an extended trip or leave from the residence hall.

5. If the student is not found in the room, the residence staff will attempt to gain information on the student's whereabouts from roommates, other members of the residential community, or other friends. The residence staff will also attempt to acquire additional phone numbers for the subject student (if not already on file) and use them to initiate contact.
6. At any step in the process, staff members will immediately report any suspicious findings to their supervisor and/or law enforcement.
7. If all of these steps do not provide residential staff with an opportunity to speak with the missing resident or to learn his or her whereabouts, law enforcement will be contacted to investigate further.
8. After law enforcement engages in the investigation and determines that the student is missing, residence staff will notify the Office of the Dean of Students Services so that contact can be made (within 24 hours) with the student's parents (if the student is under the age of eighteen) or the student's confidential contact (if over the age of eighteen or emancipated).
9. If these steps provide residential staff with an opportunity to speak with the missing residential student, verification of the student's state of health and intention of returning to campus are made. If needed, a referral will be made to SFSC Advising/Counseling office. The Dean of Student Services shall contact the concerned investigating authority to reveal the student's status.

DRUGS AND ALCOHOLIC BEVERAGES

South Florida State College is a Drug-Free Work Place and a Drug Free School. College employees and students are prohibited from the unlawful possession, use, or distribution of illicit drugs and alcohol on college property or as part of college activities. Information concerning the availability of drug or alcohol counseling, treatment or rehabilitation is available to employees from the Human Resource Department and available to students from the Dean of Student Services' office.

SEXUAL ASSAULT AND VIOLENCE, PREVENTION AND RESPONSE

South Florida State College provides periodic education for students, faculty and staff about sexual assaults, acquaintance rape, domestic violence, dating violence, stalking, and other forcible and non-forcible sex offences.

If you are the victim of a sexual assault or violence at SFSC, your first priority is to go to a place and ensure your safety. It is the victim's choice if they wish to report the incident. The SFSC Security Department strongly advocates that a victim of sexual assault report the incident. Time is a critical factor for evidence collection and preservation. To make a report to law enforcement call 911. To file a report with the college, contact campus security or any designated responsible employee/campus security authority.

The Title IX Coordinator or Duty Title IX Coordinators will oversee SFSC's report/investigation process and provide additional resources/accommodations to the victim (e.g. change the victim's

academic, living, transportation, and working situation) if requested and reasonably available, regardless of whether the victim chooses to report the crime to campus security or local law enforcement. In addition, if the victim chooses to report the incident to law enforcement, the college staff will aid in the investigation process.

Students or employees who are victims may seek guidance and/or a referral from either the Title IX Coordinator or Duty Title IX Coordinators for available community assistance programs on counseling, health services, mental health, victim advocacy, legal assistance, and other services available.

In the college discipline action, the accused and accuser will have the same opportunity to have others present during the disciplinary proceeding. Both the accuser and the accused will be informed of the outcome of the disciplinary proceeding. This action does not violate the Family Educational Rights and Privacy Act (FERPA). If a student is found to be guilty of sexual misconduct, various sanctions may be imposed, up to and including expulsion.

SEXUAL PREDATOR OR OFFENDER NOTICE

Federal and State law requires a person designated as a sexual predator or offender to register with the Florida Department of Law Enforcement (FDLE). FDLE is then required to provide notification to the local law enforcement agency where the registrant resides. If the registrant is enrolled, employed or carrying on a vocation at SFSC, FDLE must also provide the local law enforcement agency with that information. The Dean of Student Services maintains information on student sexual predators or offenders at SFSC. REPORT DEFINITIONS

Aggravated Assault: An unlawful attack by one person upon another for the purpose of inflicting severe or aggravated bodily injury. This type of assault usually is accompanied by the use of a weapon or by means likely to produce great bodily harm or death.

Arson: Any willful or malicious burning or attempt to burn, with or without intent to defraud, a dwelling house, public building, motor vehicle or aircraft, personal property of another, etc.

Arrest Persons processed by arrest, citation, or summons

Battery: Unlawful use of any physical force on another person, including beating or offensive touching without the person's consent.

Burglary: The unlawful entry into a building or other structure with the intent to commit a felony or a theft.

Dating Violence: The term “dating Violence” means violence committed by a person who is or has been in a social relationship of a romantic or intimate nature with the victim; and where the existence of such relationship shall be determined based on the reporting party’s statement and with consideration of the length of the relationship, type of relationship, and the frequency of interaction between the persons involved in the relationship.

Referral for Disciplinary Actions

The referral of any person to any official who initiates a disciplinary action of which a record is established and which may result in the imposition of a sanction.

Domestic Violence: The term “domestic violence” includes felony or misdemeanor crimes of violence committed by a current or former spouse (or intimate partner) of the victim, by a person with whom the victim shares a child in common, by a person who is cohabitating with or has cohabitated with the victim as a spouse (or intimate partner), by a person similarly situated to a spouse of the victim under the domestic or family violence laws of the jurisdiction in which the crime of violence occurred; or by any other person against an adult or youth victim who is protected from that person’s acts under the domestic or family violence laws of the jurisdiction in which the crime of violence occurred.

Drug Law Violations: Violations of laws prohibiting the production, distribution, and/or use of certain controlled substances and the equipment or devices utilized in their preparation and/or use. The unlawful cultivation, manufacture, distribution, sale, purchase, use, possession, transportation or importation of any controlled drug or narcotic substance.

Hate Crime: Any act of intimidation, harassment, physical force, or the threat of physical force directed against any person or family, or their property or advocate, motivated either in whole or in part by hostility to their real or perceived race, ethnic background, national origin, religious belief, gender, disability, or sexual orientation, with the intention of causing fear or intimidation, or to deter the free exercise of enjoyment of any rights or privileges secured by the Constitution of the laws of the United States or the State of Florida.

Liquor-Law Violation

Violations of state or local laws or ordinances prohibiting the manufacture, sale, purchase, transportation, possession, or use of alcoholic beverages, not including driving under the influence and drunkenness.

Murder and Non-negligent Manslaughter

The willful (non-negligent) killing of one human being by another.

Manslaughter by Negligence

The killing of another person through gross negligence

Motor Vehicle Theft: The theft or attempted theft of a motor vehicle.

Robbery: The taking or attempting to take anything of value from the care, custody, or control of a person or persons by force or threat of force or violence and/or by putting the victim in fear.

Sexual Assault: Means an offense classified as a forcible or non-forcible sex offense under the uniform crime reporting system of the federal Bureau of Investigation

Rape – The penetration, no matter how slight, of the vagina or anus, with any body part or object, or oral penetration by a sex organ of another person, without the consent of the victim. This offense includes the rape of both males and females.

Fondling – the touching of the private body parts of another person for the purpose of sexual gratification, without the consent of the victim, including instances where the victim is incapable of giving consent because of his or her age or because of his or her temporary or permanent mental incapacity.

Incest –Sexual intercourse between persons who are related to each other within the degrees wherein marriage is prohibited by law.

Statutory Rape – Sexual intercourse with a person who is under the statutory age of consent.

Stalking: The term “stalking” is defined as engaging in a course of conduct directed at a specific person that would cause reasonable person to- Fear for the person’s safety or the safety of others; or suffer substantial emotional distress.

Weapons Violations: Violation of laws or ordinances prohibiting the manufacture, sale, purchase, transportation, possession, concealment or use of firearms, cutting instruments, explosives, incendiary devices or other deadly weapons.

2016 Annual Fire Safety Report

The Jacaranda Hotel – A Student Residence Facility

On August 14, 2008, the Higher Education Opportunity Act was signed into law. In order to comply with this act, the college has prepared this report, which includes required information about student housing fire safety systems, fire drills, fire safety policies and education and training programs.

FIRE SAFETY EQUIPMENT AND PLANS FOR FUTURE IMPROVEMENT

To ensure fire safety for our students at the Jacaranda Hotel, the hotel is equipped with fire sprinklers throughout the entire structure. The hotel also has an integrated fire alarm system which notifies the Avon Park Fire Department upon activation. Fire extinguishers are mounted within a short distance from each resident's room. The hotel is also equipped with automatic fire doors which close and section off the building to prevent the rapid spread of fire. In addition the hotel receives annual fire safety inspections. At this time we have no fire safety enhancements planned for this facility. This facility is compliant with state and local fire codes.

SUPERVISED FIRE DRILLS

Mandatory, supervised fire drills are conducted annually for our residence halls. These drills are conducted in a coordinated effort with resident staff, supervisors, students, and/or the local fire department having jurisdiction. During the 2015 year, we conducted one fire drill On September 28, 2015. This was to ensure all residents were aware of the proper evacuation routes in case of an actual fire. All residence hall rooms are equipped with evacuation maps posted by the door which indicate the safest and most direct exit routes from the room in the case of an emergency.

EDUCATIONAL FIRE SAFETY TRAINING PROGRAMS

Student residents attend an *Orientation/ Welcome to Dorm Life* meeting. During this meeting staff conducts a mandatory house meeting for students during which evacuation procedures and fire safety rules are reviewed with new and returning residents.

Students are prohibited from smoking in their rooms, having candles or burning incense. No open flame cooking devices are allowed in dorm rooms nor can flammable fluids be stored. Many small electrical appliances are also prohibited; included in this list are space heaters, hot plates, coffee makers and toasters; however, electric irons are permitted.

The college's Employee Safety Manual has been developed to provide staff with information on various safety related issues. Included in this manual is a section on fire safety.

STUDENT HOUSING EVACUATION

In the event of a fire at the Jacaranda Hotel, the fire alarm system will be activated. Students should consult the nearest egress maps for familiarity with emergency evacuation routes. Students can also be guided to the nearest exit by following the overhead exit signs. Emergency stairwells are located on the east and west side of the building along with a stairwell in the middle. Elevators should not be used in a fire evacuation. When students exit their dorm rooms, they should close the doors behind them (but not lock them). This will minimize the rapid spread of the fire through the structure.

PROCEDURES FOR REPORTING A FIRE

All fires should be reported immediately by calling 911. Please pull the nearest fire alarm “pull station”, this will activate the fire alarm and start the building’s evacuation process.

South Florida State College maintains an official statistical Fire Log which documents all reported on-campus student residential fires. Individuals should report all residential fire occurrences to the SFSC Foundation, Inc. office and the Coordinator, Residence Life even if the fire was small and was immediately extinguished (e.g. stovetop cooking fire). Information that will be collected will consist of: the nature of the fire, the date of the fire occurred, the time of day the fire occurred, and the general location of the fire. SFSC’s Fire Log is open to public inspection.
