# SFSC's Veronica Molina Receives First Generation College Scholarship

Veronica Molina, a Hardee Senior High School graduate, has been awarded a scholarship through the First Generation Scholarship Program, covering up to 60 credit hours of college tuition.

The First Generation Scholarship Program supports the efforts of higher education through scholarship funding for first generation students who aspire to attend a Florida college or university. A student is considered "first generation" if neither of the student's parents earned a college degree at the baccalaureate level or higher. This scholarship was made available through a partnership between the SFSC Foundation, Inc. and the Florida Prepaid College Foundation.

"It's with extreme excitement that we announce Veronica Molina as the recipient of our First Generation Scholarship," said Jamie Bateman, executive director of institutional

# Tax Reform Act Impacts Charitable Giving

You may be wondering how you will be affected by the Tax Cuts and Jobs Act of 2017, which was enacted last December. It is the most significant tax legislation since the Tax Reform Act of 1986, and it affects businesses, individuals, and, to some extent, gifts to charitable organizations, like the SFSC Foundation.

This is an excerpt from "The Tax Cuts and Jobs Act: Charitable Strategies for 2018," which appears on the Pentera blog (pentera.com/blog). It explores charitable strategies to consider this year.

Increase your charitable gifts so you can benefit from itemizing your deductions. If the total of your itemized deductions is going to be close to the new higher standard deduction amount (\$12,000 for single filers and \$24,000 for married couples filing jointly), you might consider giving more to charity in 2018 so that your income-tax charitable deduction helps you exceed the standard deduction amount and you can itemize and receive the tax benefits of doing so.

Make gifts of appreciated securities. You can still save capital gains taxes by giving appreciated securities that you have owned for more than a year.

### Make retirement-plan gifts.

A simple and smart way to make a charitable gift is through retirement-plan beneficiary designations. While your loved ones are subject to paying income tax on retirement-plan gifts they received, charities such as the SFSC Foundation are not. Your gift can help loved ones save taxes by giving them other assets and making retirement-plan gifts to charity.

Make an IRA rollover gift.

Those over the age of 70 ½ who have not yet taken the required distribution from their IRA might ask their IRA administrator to make a direct tax-free transfer to charity.

Make a gift that costs nothing now. A bequest in your will or trust continues to be a way to make a significant gift that costs you nothing now. There are many ways to design your bequest to best meet your family priorities and charitable objectives.

# Khao Hlee Lor: Take Stock Graduate Finds Purpose as Special Education Teacher

# TAKE STOCK IN CHILDREN SCHOLAR SPOTLIGHT

My Take Stock in Children experience was a blessing. To this day, I still believe I attended college because of the opportunities my scholarship provided for me. When I received my scholarship, the reality of college became solid and real. I realized it can actually be a part of my future and not just another dream.

I attribute a big part of my success to my Take Stock support system. They were my foundation from middle school to after college. I had a lot of questions about college, some of which I did not know how to phrase out loud. Yet, they sat, listened, and answered every one. I had the benefit of Take Stock personnel, who I turned to with questions about graduation requirements, college applications, financial aid, and resources for academic success. Then, I had my designated mentor that I met with weekly for concerns and celebrations pertaining to school. Joann McCray continued to monitor, encourage, and support my education through college.

I attended the University of Florida with my Take Stock scholarship and stayed there for four and a half years. My scholarship played a role in avoiding student loans during my undergraduate years. In December 2015, I graduated with my bachelor's degree in elementary education. I fell in love with what I was learning, so I decided to continue my education another year. In December 2016, I graduated with my master's degree in Special Education, complete with endorsements in reading and English for Speakers of Other Languages.

The spring following college graduation, I worked as a substitute teacher for a few months until the

end of the school year. Then, I could not decide if I should stay where I was or return home to start my teaching career. After much discussion with my mentor, I decided to return home. It felt right.

I accepted a fourth grade teaching position at Zolfo Elementary School. Last year, I taught my first inclusion class, a model for students with disabilities to learn alongside their nondisabled peers in a general education class. I love working with the students and other colleagues who share the same passion as me, which is to see these students succeed.

If it had not been for my Take Stock scholarship and my mentor, I do not think I would be where I am today. They turned my dream of attending college into a goal, and together we built steps that I could take to achieve that goal. Now, I have come full circle. I am back where I first started with Take Stock, and I am working with students to build goals for themselves. I hope I can continue to keep this cycle going for generations to come.

# SFSC Alumna Jazmin Caton Receives Doctorate

Jazmin Caton, an SFSC alumna and the first person in her family to graduate with an advanced degree, has been awarded a doctorate in Higher

Administration and Policy from the University of Florida (UF).

"Education was always a priority in terms of expectations that my parents and family set for me and I adopted that for myself," Caton said.

While completing a geneaology project in a fourth grade class for gifted students at Sun 'n Lake Elementary School, Caton was required to interview family members and write a reflective piece on her personal goals. "I said that when I grew up, I was going to have a doctorate in education and open a school," she said. "I've accomplished one of those two goals."

While attending Sebring High School, Caton participated in SFSC's dual enrollment program that allowed her to take classes that applied toward high school and college graduation. Her decision was partly influenced by her father, Eddie Cuencas, the program specialist for the Panther Youth Partners program at SFSC.

After receiving her Associate in Arts degree from SFSC, Caton earned a Bachelor of Science in Public Relations from UF in 2009. Along with working in a part-time public relations job, Caton served as an orientation leader at UF and a peer mentor, student leader, and house manager for the Southern Scholarship Foundation, which provided her with a housing scholarship. She has since been appointed to its board of directors.

As an undergraduate, Caton made the leap from public relations to working on a Master of Science in Family and Child Sciences from Florida

State University (FSU).

"I learned that I have a natural affinity for the work of public relations specialists — seeking out and cultivating relationships to disseminate information about organizations," she said. "But I wanted to gain more expertise in a discipline. I was drawn to nonprofit organizations and programs that help people. I wanted to be able to become an expert in human development."

She then entered graduate school at Florida State University (FSU) and was soon presented with an opportunity to work for the FSU Autism Institute on a research project. "It was a grassroots program and hadn't been operating long. We made major gains in research funding and communication awareness to identify key messages. The State of Florida started paying more attention to us. My experience there helped me understand why people are who they are and why they become who they become. And I was able to use my skills in strategic communications taking messages from our research and communicating them to the appropriate audiences."

"When working from research, one of the greatest challenges is providing the results of that research to the people who need it most," Caton said. "Facing that challenge influenced me to want to be a leader in the administration of programs and projects that have critical information and services to offer people who need them most."

Caton sees the doctorate as a convergence of her knowledge base in human development and her skill set in strategic communications. "I was chasing opportunities to lead others and provide management and coaching. Receiving a doctorate in higher education administration felt like the landing place for those goals. I felt that being in an institution of

higher education or a support program of higher education was how to get to the goal of helping people in the way that has great return for them and the community."

Caton has taken her passion for human development and communications beyond the academic world. She plans to rewrite her doctoral dissertation for a new audience. It's titled, "They Already Have So Many Labels: Defining Homelessness in the Context of Higher Education" and it focuses on homelessness among college students. "A recent study showed that 14 percent of community college students and 9 percent of university student are homeless," Caton said. "My purpose was to explore the issue more specific to higher education—taking a closer look at how students and institutions understand, define, and support this issue of homelessness within this context."

Now, she is working on a research project that explores childcare access within the community college system and the U.S. Department of Labor's initiatives to increase access for students who are responsible for children. "Our case study will explore the implementation of this initiative and what these programs look like two years after receiving funding. We're looking at practices at institutions that are promising for students who need access to child care. Lack of adequate child care can be a barrier to the completion of a parent's education and a hindrance to their children's future education as well."

As a means of giving back to the Highlands County community and the high school they graduated from, Caton and her husband, Tyler, created a \$500 annual scholarship that is awarded to two Sebring High School swim team seniors. The Catons attribute their success to their involvement with the swim team and Tyler's mother, Patricia J. Caton, a teacher and coach.

# SFSC Earns Gold Status for Second Year

For the second year in a row, SFSC has been awarded gold status from the Florida College System (FCS). SFSC was one of five FCS institutions out of 28 to earn gold for 2018-19.

"It is thrilling that SFSC received this prestigious recognition for two consecutive years," said Dr. Thomas C. Leitzel, president of SFSC. "The rating puts SFSC among a group of elite Florida colleges and affirms the commitment to excellence in student services combined with quality learning initiatives led by committed members of the faculty."

The FCS uses a Performance

Funding Model to determine whether its institutions receive gold, silver or bronze. Using a 40-point scale, the FCS evaluates each institution on retention rates, completion rates, job place/continuing education rates, and entrylevel wages. This year, there were five gold, 18 silver, and five bronze colleges. The points are distributed based on Improvement and Excellence, with comparisons between last year's and this year's data. SFSC scored 39.64, making it the second highest-ranked FCS institution in the state.

"At SFSC, we are honored to be a gold status college once again," said

Tami Cullens, chair of the board of trustees for SFSC. "This speaks well of our commitment to serving the students in our district and the dedication of our administration, faculty, and staff in making a difference in the lives of all who attend this great institution."

For 2018-19, the Florida Legislature and governor allocated \$60 million of general revenue to performance funding. Gold category colleges will receive their proportional share of the State's funding and a point-proportional share of the funds that would have been available to the bronze-status colleges that scored 29.01 points and below.

# Four Endowed Chairs Selected

Funding through the SFSC Foundation has made it possible for four SFSC faculty to receive endowed teaching chairs.

Darlene Saccuzzo, dental education professor, was appointed as the Highlands County Health Facilities Authority (HCHFA) Endowed Chair in Dental Education. Dawn Pisarski, nursing professor, was appointed as the HCHFA Endowed Chair in Nursing Education. The Norm and Laurie Stephens Endowed Teaching Chair went to Bob Sconyers, dental assisting professor, and the Carol Emery Endowed Chair in Mathematics went to Cheryl John, developmental mathematics professor.

Recipients of endowed teaching chairs receive \$5,000 per year for two years. Half goes toward equipment, professional development, or to attend a conference related to the faculty member's discipline of study. The other half is a salary stipend.

Saccuzzo is using part of her award to offer new technology that delivers intense one-on-one instruction to dental education students. Pisarski's award will send two or three SFSC nursing faculty to the American Holistic Nurses Association annual conference, where they will learn best practices for incorporating self-care into daily life.

Sconyers will attend a conference about the latest in dental materials and equipment and will purchase cutting edge technology for the classroom. Johns is using her award to develop math boot camps for students to take prior to taking the diagnostic testing required for placement into college mathematics courses.

Endowed teaching chairs at state and community colleges are modeled after research chairs at universities. "This program gives us a way to show appreciation for excellence in teaching," Jamie Bateman said.
