

## 2022-2023 Federal Direct Student Loan Request

- For PSAV/Vocational programs you must be enrolled in **eight hours** or more to receive a Federal Direct Student Loan. If not enrolled, loan will not be processed.
- Your requested loan amounts may be adjusted based on your cost of attendance to comply with federal regulations.
