Nomination Criteria

The following criteria are considered in determining the recipients of the SFSC Alumni of the Year Award:

- 1) The nominee must be a graduate of SFJC, SFCC, or SFSC at least five (5) years ago.
- 2) The individual has demonstrated excellence and growth in his/her vocation, and/or has shown distinguished service and recognized leadership in his/her work community.
- 3) The individual is a giving person as demonstrated by one or more of the following: community service, church service, political service, and/or charitable service.
- 4) Nominations may be made posthumously.

Submission

Nominations will be accepted through:

- 1) Postal mail using this official Panther Alumni Society Hall of Fame Nomination Form (download PDF). Please include any supporting documentation with the nomination form. Mail must be postmarked **by Friday, Oct. 31, 2025**. Submissions received after the postmarked deadline will not be considered.
- 2) Online nomination form is available. Please be sure to upload any supporting documentation with your nomination submission.

Nomination Deadline

All nominations **MUST** be received by **Friday, Oct. 31, 2025**.

Please do not notify your nominee that he or she has been submitted for consideration, as the nomination is not a guarantee of award selection. Public announcements will be made prior to the induction ceremony on Thursday, Dec. 4, 2025.
