Federal Direct Student Loan Request

- All sections must be legibly completed to be appropriately processed.
- A current-year FAFSA (Free Application for Federal Student Aid) must be on file before a student loan can be processed.
- **First Time Borrowers** loans will disburse 30 days from start date once approved.
- You must be enrolled in **six credit hours** or more to receive a Federal Direct Student Loan. **Please note; If enrolled in Flex Terms, the loan will not be disbursed until six credit hours are reached (i.e., Flex A 3 credit hours, Flex B 3 credit hours, loans disbursed after Flex B)**
- For PSAV/Vocational programs you must be enrolled in **eight hours** or more to receive a Federal Direct Student Loan. If not enrolled, the loan will not be processed.
- Your requested loan amounts may be adjusted based on your cost of attendance to comply with federal regulations.
